**NOTIFICATION**  
**SRINAGAR DATED THE 24<sup>TH</sup> MAY, 2011**

Whereas, a detailed schedule for the conduct of General Election to the Panchayats in the entire State was issued by this office on 14<sup>th</sup> March, 2011;

Whereas, the schedule for the conduct of Panchayat Election in respect of some blocks falling in the Districts of Bandipora, Shopian, Leh and Kargil was issued vide No.5311/CEO/PYT/Notification/2011/5900-04 dated 3-5-2011, on the basis of proposals/requests submitted by the concerned District Panchayat Election Officers (Deputy Commissioners);

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Kargil had vide his letter No.DPEO-K/Elec/P-MF/2010/13 dated 21-05-2011, recommended that the Panchayat Elections for the Zanskar and Lungnak Blocks should be held in the last week of June or the first week of July, 2011 keeping in view the fact that the Kargil – Zanskar road is likely to be re-opened in the 1<sup>st</sup> / 2<sup>nd</sup> week of June, 2011;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Kargil has now intimated that as the road from Kargil – Zanskar has been opened for vehicular traffic from 17<sup>th</sup> May, 2011, the Panchayat Election for the Zanskar and Lungnak Blocks may be preponed and may be scheduled to be held in the last week of June, 2011;

Therefore, keeping in view the request of the District Panchayat Election Officer (Deputy Commissioner) Kargil and in supersession of all previous notifications the schedule for the conduct of elections in the Zanskar and Lungnak Blocks of Districts Kargil is fixed as under:-
