2. The appointees shall report to District Election Officer, Jammu. In case any appointee fails to join within the stipulated period of 21 days his appointment shall be cancelled without any further notice. The appointees shall be posted after their joining report is received in this office.

3. The appointees shall be allowed to join only on production of the following certificates/documents in original which shall be verified subsequently from the concerned quarters;-

1. Academic qualification certificates.
2. Date of Birth Certificate.
3. Health Certificate, issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category certificate (in case candidate belongs to Reserved Category)
6. Certificate from General Manager, District Industries Centre concerned and Deputy Director Employment concerned to the effect that no loan is outstanding against the appointees under any scheme.

4. The appointments of the above as Election Assistants (Jr. Scale) shall further be subject to the following conditions;-

- a) The appointee shall give an undertaking duly attested by judicial Magistrate to the effect that in case adverse report about his Character and Antecedents is received from the Director General of Police, CID, J&K to whom a reference shall be made by the department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.
- b) The verification report of Qualification Certificate/Reserved Category Certificate (wherever necessary) from the concerned quarters/issuing authority, and if any of these are found to

be invalid, fake or incorrect, the appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.

The salary of the appointees shall not be drawn and disbursed unless satisfactory report in respect of (a) and (b) above is received. The appointment of the above shall be governed by the "New Pension Scheme" as per SRO. 202 of 2015 dated 30-06-2015.

5. The appointees shall be on probation for a period of five years.


6. The inter-se-seniority shall be in the order in which the appointees appear in the select list furnished by the J&K Service Selection Board.
