## **Press Release: Kind attention of Kashmiri Migrant Electors**

Special Revision of Municipal Electoral Rolls, 2018 for various Municipal Committees, Municipal Councils and Municipal Corporations of the State, with 01/01/2018 as the qualifying date, is going on. The draft roll has been published on 4<sup>th</sup> August, 2018, with issuance of public notices giving relevant details, which have been widely publicised and are also available on the CEO website: <http://ceojk.nic.in>.


Representations have been received from Kashmiri Migrant Electors with regard to the municipal ward in which they may be enrolled. In the draft rolls that have been prepared on the basis of the Assembly electoral rolls, they are figuring in the electoral roll of the wards of the municipal bodies of Kashmir division. It is clarified that as the Assembly Electoral Rolls are relatable to the municipal areas and the persons registered as voters for the Legislative Assembly are entitled to vote for the Municipal areas also, the migrants shall continue to form a part of the electoral roll of the relevant municipal body in Kashmir Division. Arrangements shall be made for casting of votes by them through postal ballot.

For the facility of the Kashmiri Migrant electors, they can check the draft Municipal Electoral Rolls that are available with following Assistant Electoral Registration Officers (Migrants):-

1. Deputy Director, Horticulture, Planning and Marketing, New Delhi
2. Assistant Commissioner, Relief (Migrant) Jammu
3. Collector, Northern Railways, Udhampur

For addition/deletion/correction/transposition, the applicants are required to fill the prescribed forms, available with the Assistant Electoral Registration Officer (Migrants) or they can file the claims/ objections by electronic means by logging on to <http://ceojk.nic.in/efiling>.
