**STATE LEGISLATURE (PREVENTION OF DISQUALIFICATION ACT, 1962)****STATEMENT OF OBJECTS AND REASONS**

At present a member of the State Legislature is debarred from accepting an office of a Chairman, Director or a member of a Government owned or controlled corporation etc. It has accordingly been found necessary to replace the existing law on the subject so as to bring it in line with that in force in the rest of the Country.
