Srinagar, the 28th October, 2014.

SRO-459.—Whereas, in accordance with the provisions of sub-section (1) of section 52 of the Constitution of Jammu and Kashmir, the existing Legislative Assembly of the State of Jammu and Kashmir, unless sooner dissolved, shall continue up to and including the 19th January, 2015 (Monday) and shall, thereafter, stand dissolved on the expiration of its duration; and

Whereas, in terms of sub-section (1) of section 27 of the Jammu and Kashmir Representation of the People Act, 1957 (IV of 1957), a general election has to be held for the purpose of constituting a new Legislative Assembly of the State.

Now, therefore, as recommended by the Election Commission of India in pursuance of sub-section (2) of section 27 of the said Act, the Governor of the State of Jammu and Kashmir is hereby pleased to call upon the following Assembly Constituencies in the State, to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder, namely:—

- 2. Now, therefore, in pursuance of sections 41 and 66 of the said Act, the Election Commission of India hereby:—
  - (A) appoints, with respect to the said election in each of the constituencies.—
    - (a) the 05th November, 2014 (Wednesday), as the last date for making nominations;

- (b) the 07th November, 2014 (Friday), as the date for the scrutiny of nominations;
- (c) the 10th November, 2014 (Monday), as the last date for the withdrawal of candidatures;
- (d) the 25th November, 2014 (Tuesday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 29th December, 2014 (Monday), as the date before which the election shall be completed.
- (B) fixes the hours from 8.00 A. M. to 4.00 P. M. as the hours during which the poll shall, if necessary, be taken in each constituency on the date specified in the Schedule below, for the election
