Jammu, the 7th November, 2014

SRO 483.- Whereas, in accordance with the provisions of sub-section (1) of section 52 of the Constitution of Jammu and Kashmir, the existing Legislative Assembly of the State of Jammu & Kashmir, unless sooner dissolved, shall continue up to and including the 19th January, 2015 (Monday) and shall, thereafter, stand dissolved on the expiration of its duration; and

Whereas, in terms of sub-section (1) of section 27 of the Jammu and Kashmir Representation of the People Act, 1957 (IV of 1957), a general election has to be held for the purpose of constituting a new Legislative Assembly of the State;

Now, therefore, as recommended by the Election Commission of India in pursuance of sub-section (2) of section 27 of the said Act, the Governor of the State of Jammu and Kashmir is hereby pleased to call upon the following Assembly constituencies in the State, to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder, namely:-
