 - 3. Vouchers may not be attached only in respect of those items which are listed in Rule 86 (b) of the Conduct of Election Rules, 1965 like postage, travel by rail. For any voucher not attached vide this rule, an explanation to the effect that it was not practicable to obtain the required vouchers must be given in the prescribed Register.
 - The account shall be countersigned by the candidate if it is lodged by his election agent and should be certified by
 the candidate himself to be correct copy of the account kept.
 - 5. A part from the expenses incurred or authorised by the candidate/election agent directly, all expenditure incurred or authorised by the political party, other associations, bodles of persons, individuals, in connection with the election of the candidate are also required to be included in the account. The only exception is the expenses incurred on travel of 'leaders' of the political party on account of their travel for propagating the programme of the party. [See explanations 1 and 2 of Section 85 (1).]
 - 6. If the expenditure on any item shown above in column 2 is incurred/authorised by any political party/association/ body of persons/any individual (other than the candidate or his election agent), its/his name and complete address must be shown in column 4.
