THEREFORE, IT IS FOR THE CLARIFICATION OF ALL DPEOs' THAT AFFIDAVIT IN FORMAT OF APPENDIX-M6 AND M6a (GIVEN IN THE HANDBOOK FOR RETURNING OFFICERS) SHALL ONLY TO BE OBTAINED FROM CANDIDATES DURING THE FILING OF THE NOMINATION PAPERS (.)
