ENT/J/2020/1705-1760 Dated:27-10-2020, I, **Sushma Chauhan, IAS, Deputy Commissioner, Jammu** do hereby notify the revised draft reservation of District Development Council Constituencies as Annexure — A to this notification and invite objections/suggestions to the same.
