If, with reference to the above said qualifying date, there be any claim for the inclusion of a name in the roll or any objection to the inclusion of name or any objection to particulars in any entry, it should be lodged on 9th of Nov 2022 or before the 08th of December, 2022 in Forms 6, 6A, 7 or 8 as may be appropriate.

An eligible Citizen, who is going to attain the age of eighteen years on any of the subsequent qualifying dates in the year 2023 that is to say the 1st April, 2023 the 1st July, 2023, or the 1st October, 2023, may also file his or her claim for inclusion of his or her name in the roll, in Form-6 in advance, starting from the date of notice, and the same shall be considered and decided in the respective quarter of the year with reference to the respective qualifying date.

Every such claim or objection should either be presented in my office or in the offices AERO / BLOs or should be filed online through Voter Help Line App and NVSP portal (nvsp.in) or should be sent by post on the address given below not later than the aforesaid date:
