

No. 322/J&K-LC/2013 (1).—WHEREAS, the Governor of the State of Jammu and Kashmir has, by notification issued under section 29 of the Jammu and Kashmir Representation of the People Act, 1957 (IV of 1957) and published in the official Gazette of the State on 11th February, 2013 (Monday), been pleased to call upon the members of the Legislative Assembly of the State, to elect eight members to the Legislative Council of the State, as specified below :—

- (a) 4 (four) members from amongst persons who are residents of the Province of Kashmir and are not members of Legislative Assembly ;

- (b) 4 (four) members from amongst persons who are residents of the Province of Jammu and are not members of the Legislative Assembly ; provided that of the members so elected, at least one shall be a resident of Doda District.

Now, therefore, in pursuance of sub-section (1) of section 50 and section 66 of the said Act, the Election Commission of India, hereby—

(A) appoints, with respect to the said election—

- (a) the 18th February, 2013 (Monday), as the last date for making nominations ;
- (b) the 19th February, 2013 (Tuesday), as the date for the scrutiny of the nominations ;
- (c) the 21st February, 2013 (Thursday), as the last date for the withdrawal of candidatures ;
- (d) the 7th March, 2013 (Thursday), as the date on which a poll shall, if necessary, be taken ; and
- (e) the 10th March, 2013 (Sunday), as the date before which the election shall be completed ; and

(B) fixes the hours from 10:00 A. M. to 2:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
