e) FIXED ASSETS & DEPRECIATION

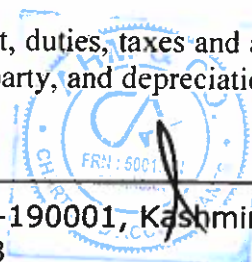

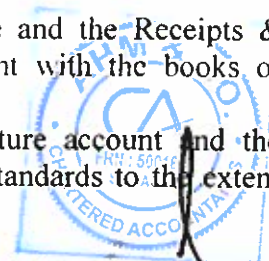

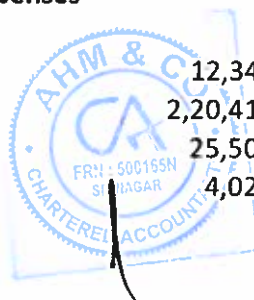
